This application must be completed by any individual seeking a driver and/or trainer license with the USTA for the first time, who currently holds a license in a foreign jurisdiction. All applicants must have current membership with the USTA in to obtain a driver and/or trainer license. If you are not a current member, you must submit a membership application (new or renewal) and membership fees with this form - membership fees are not included in the fee for a new driver and/or trainer license. Upon receipt, the foreign jurisdiction in which you are licensed will be contacted to verify your license and statistics. Drivers applying for a P or A license must also register driving colors by separate application.
